


Sharing news from the Order of St John

St John Malaysia provides vital medical facilities for those in need "I have to stop working and my family is worried about me"

Teh Seng Huat is 64 years old and has been suffering kidney failure for the last 6 years. His condition causes severe difficulty with breathing and painful swelling in the legs. The severe symptoms mean that Seng Huat could no longer work and treatment at the private clinic was becoming a huge drain on the family. It was at the right time that Seng Huat heard about the St John dialysis centre, situated nearby to where he lived. Seng Huat now visits the centre three

times a week

has been operating centres since 1993 to meet a need in the community for people experiencing serious problems with their kidneys. Kidney failure is often caused by diabetes and high blood pressure two of the fastest growing non-communicable diseases which are manifesting in every corner of the world today. The Haemodialysis service is vital for filtering out the harmful substances in the blood when the kidney is unable to do so.

St John Malaysia manages 16 dialysis centres with more than 200 machines and currently more than 500 patients under care. Much of the cost for these vital services is generated from public donations.

"St John has done a good deed for the community. If it was not for St John, a lot of patients would be unable to get the service they need" - Teh Seng Huat, St John Dialysis service user.

Big First Aid Lesson: Giving students a front row seat to First Aid

Recent news from St John England has hit the headlines as it gears up for a BIG FIRST AID LESSON to be streamed online.

Scheduled for Friday 20 June at 2 pm GMT, it's a free, one-hour, online first aid lesson streaming to 1,000 schools around the country.

Students aged from 7 to 16 years-old will get a frontrow seat to the country's largest first aid lesson, where they will learn basic skills that can save lives. During the lesson, they can join in through a live web chat, and hear stories of other students who have saved lives with first aid.

97% of teachers want to teach First Aid

Many St John organisations offer First Aid in schools with School Programmes prominent in Zimbabwe, Fiji, Sri Lanka and Ghana. St John England asked over a thousand primary and secondary school teachers across England for their views on teaching first aid. An amazing 97 per cent of teachers feel young people should learn first aid, while more than half (57 per cent) believe it needs to be added to the national curriculum to be taken seriously. Currently, just 21 per cent of teachers actually bring first aid lessons into their classrooms. A lack of time (35%), their own lack of training (33%), and cost (21%) stop more from doing this.

Hearing this, St John wanted to break down barriers for students to learn first aid and reach out to teach

them the skills now. The only equipment schools need to participate in the Big First Aid Lesson is an internet connection and a screen.

Meanwhile, St John Cymru Wales is creating a generation of lifesavers, by pledging to train 1000 pupils at one school alone as part of a First Aid Awareness Programme which has been funded by a legacy left by a local

businessman. First aid is included in the National

How Jaipal saved her friend

Jaipal Basi was 10 when her friend Joanna started choking on a piece of cucumber at school. Instinctively, she knew exactly what to do because she learned first aid at school from one of our trainers. Jaipal gave her friend five back blows and saved her friend's life.

'Everyone in year five had done the training, and I remembered straight away what I needed to do,' she said.

'First aid is really important and I feel confident that I would be able to help someone else again if they needed it.'

Curriculum in Wales however, teaching the subject isn't mandatory.

St John Wales has teamed up with the British Heart Foundation Cymru, The Red Cross in Wales and the British Medical Association Cymru to form a campaigning alliance to raise awareness of the importance of teaching emergency life skills in school. Suzanne Cass, St John Wales' Director of Fundraising and Marketing said, "Our vision is to have a first aider on every street in Wales and we believe that it is never too early to start learning first aid. At St John Wales we would like to see all children leaving school with the skills needed to save a life. We believe that first aid is as essential as learning to swim".

David Blackmore, district manager for St John
Ambulance in Devon and Cornwall,
said:

"First Aid is so easy to learn and can have such an incredible impact on people's lives. We want as many schools as possible to sign up to the Big First Aid Lesson and take advantage of the funded training we're able to offer this year." At the meeting, the Mother and Baby programme in Africa, which continues to be the number one Strategic Objective for the Order, was given further credibility.

Grand Council recognised that in an era of immediate communications around the world, what affects St John in one country can affect St John in many others. In the interests of us all, some standards must be observed by St John organisations everywhere. A constructive debate took place about removing the constitutional distinction between Priories and St John Associations. This process will take time to accomplish, and it will go hand-in-hand with the development of common standards.

Attention also focused on the role which individual members of the Order can have in the governance and development of St John and in the preservation of its values and ethos. This will be increasingly important as St John expands.

Everyone present warmly thanked St John Canada for hosting this very successful meeting of the Council. It was attended by the largest number of members ever, and it signalled St John moving forward in a more focused and purposeful way.

New life for defibrillators

When St John Western Australia's (WA) Ambulance service gets updated equipment, it makes sure nothing goes to waste.

St John Ambulance WA is sending 74 Zoll defibrillators to **shares his tribute**. overseas ambulance services that struggle to get modern reliable heart-starting equipment. The defibrillators were recently replaced by the Philips HeartStart MRx series in the WA fleet.

The older defibrillators, which are in good order, will go to various St John and non-St John organisations in Papua New Guinea, Kenya, East Timor, Malawi, South Africa and Nepal.

Chief Executive Officer Tony Ahern said "These machines will go to areas where they are needed most. Charitable work is part of the fabric that makes up St John and we're proud to carry on this work at home and overseas."
