Grand Council Meeting 2015 in Edinburgh

This year's Grand Council is the largest ever with 11 Priories (St John Hong Kong having been made a Priory in January this year) with the Order having a Chancellor for the first time, and The Hon Dr Neil Conn presiding over his first Grand Council as Lord Prior.

Hosted splendidly by St John Scotland in Edinburgh with Scottish Pipers present, a reception at Holyrood House and a conference on Infant Health - it was a memorable Grand Council in many ways with the

Council discussing new governance structure for the worldwide organisation.



During the Council, the members had a conference on Infant Health where Dr Liz Grant, Assistant Principal Global Health Director of Global Health Academy at the University of Edinburgh was the key note speaker.

During the church service held by Grand Council, the new Prior of Scotland Major General Mark Strudwick CBE was invested as a Knight of the Order (see page 2 for more details).

Europe Regional Meeting 2015

In the days preceding Grand Council, the Priory of Scotland hosted a European Regional meeting. With representatives from the Priories of England, Scotland and Wales, The St John Associations of Gibraltar, Malta and Cyprus, the Commandary of Ards (Northern Ireland) and the associated organisation of St John Ambulance Ireland attending.

All participants felt that the meeting had been hugely successful with a full agenda discussion which also reestablished some important links between Priories and Associations that will bear fruit in a short period.

Major General Strudwick becomes KStJ

Major General Mark Strudwick, who will succeed Sir Malcolm Ross as Prior of the Priory of Scotland, has been invested as a Knight of the Most Venerable Order of the Hospital of St John of Jerusalem at a ceremony at the Canongate Kirk in Edinburgh on Tuesday 26 May.

Delegates to the Grand Council joined members of St John Scotland to see the former General Officer Commanding the Army in Scotland admitted to the Order by the Lord Prior, Dr Neil Conn.

Sir Malcolm is stepping down in June after the maximum two terms, six years in office. General Strudwick will be installed as Prior at the annual service at Torphichen Preceptory on Sunday August 30.

St John Scotland support for Mother and Baby Programme

Following the reception evening on Thursday 21 May at the Roxburghe hotel, St John Scotland has launched their support for the St John Mother and Baby Programme in Malawi and Zambia.

The funds will be used to help train volunteers within communities to provide support to women during pregnancy and delivery, and to mothers and newborn children in the critical periods after birth.

Sir Malcolm Ross, Prior of St John Scotland:

"I am immensely proud that we are able to support the mother and baby programme in conjunction with St John International and other St John establishments in Africa to help save mothers and newborn babies lives. It fits exactly with our aim of helping to improve the safety, health and quality of life of people in need."

David Hope-Jones, Principal Officer of the Scotland-Malawi Partnership described the work of St John as "fantastic".

He added: "I'm really excited to learn more about this new project which is going to go from strength to strength over the next few years.

"If we stand together, not as two nations, but as one nation in our fight International to address the extreme poverty in Malawi in a dignified partnership where both benefit and both contribute, I think that's where the real change is going to come."

Providing humanitarian aid for Nepal Earthquake victims



On 25 April, a magnitude 7.8 earthquake struck central Nepal and just over two weeks later, on 12 May, a second major earthquake hit the country. Current reports suggest 8,000 people have been killed as a result of the first earthquake, with thousands more injured.

St John Ambulance Malaysia (SJAM) has continued to provide relief aid to those affected by the earthquakes in Nepal. With a generous donation of RM100,000 recently from Berjaya, one of Malaysia's largest corporations; SJAM will purchase a four- wheeled ambulance vehicle to help transport victims from disaster sites to the hospital.

SJAM staff and volunteers in Nepal

SJAM commander-in-chief Datuk Dr Low Bin Tick said: "We are in contact with the National Eye Hospital of Kathmandu and have met the Nepal ambassador to Malaysia with regards to the fund. We were informed that the one thing they need very urgently is an ambulance. So we will be using this fund to get a vehicle for that purpose. Although it will not be a fully equipped ambulance, it will certainly be very useful to transport victims."

In late May, a nine-member SJAM team including three doctors travelled to the disaster zone for its relief mission and have provided first aid and medical care to members of the communities.

donation to help the victims.


Working with the Kenya National Blood Transfusion Service and Bloodlink Foundation, St John Kenya set up the facility for volunteers to donate blood at a major bus terminal in the centre of Nairobi.

Rima will remain connected to St John through her involvement with the Women's Guild which supports the Eye Hospital.

The Secretary General said that the Order has been particularly lucky having had someone of Rima's expertise ensuring the Order was financially fit for all its tasks in the future.

St John Jamaica receives grant to help children affected by HIV/ AIDs

Over 100 children infected and affected by HIV/AIDS will benefit from psychological, educational and social support under a J\$8 million (US\$70,000) grant assistance programme provided by the United States Agency for International Development (USAID) in partnership with World Learning.

The four-month initiative that will be carried out through three non-governmental organisations (NGOs) which includes Jamaica AIDS Support for Life, EVE for Life, and St John Ambulance in Jamaica.

The programme will provide training for parents/caregivers, as well as increase the skill set of an existing volunteer corps to provide ongoing mentorship and psychological support to orphans and vulnerable children.

Alison Binger, Executive Director of St John Jamaica, commented, "Through our first aid and home care offerings we intend to increase our capacity to reach and serve the needs of orphans and vulnerable children, and their families. This will be done via capacity building of existing volunteers and members as well as developing a corps of volunteer counsellors who will provide psychosocial and general care for these children and their communities."


St John Ambulance Canada Life-Saving Award presented at annual Day on the Hill

During the annual Day on the Hill where St John Ambulance Canada enagage with Canadian parliamentarians about community services and first aid, a life-saving award recipient was recognised at an evening reception.

Christine Gregory, a nurse from the Children's Hospital of Eastern Ontario, used her first aid skills to save a life. During a visit to the local garage for an oil change on 27 June 2014, one of the mechanics, Terry Kerr suddenly collapsed.

Christine assessed his condition and found him to be unconscious, not breathing and without a pulse. She immediately began CPR and continued chest compressions until the Emergency Services arrived with an automated external defibrillator. The casualty regained consciousness and was transported to hospital.

Christine Gregory is to be commended for her quick actions, calm response and for her knowledge and use of first aid in saving a life.
